<b>What is the overall <a href="#">deductible</a>?</b>	\$2,000 individual/\$4,000 family medical <a href="#">deductible</a> ; per plan year	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. <a href="#">Preventive care</a> , primary care, <a href="#">specialist care</a> , services are covered before you meet your <a href="#">deductibles</a> .	This <a href="#">plan</a> covers some items and <a href="#">services</a> even if you haven't yet met the annual <a href="#">deductible</a> amount.
