Minimum participation	35 people Can be either members or non-Tufts Health Plan members. If fewer than 35 individuals attend, client will be billed for the number of doses needed to reach the 35 minimum.	50 participant billing minimum. Can be either members or non-Tufts Health Plan members. If fewer than 50 individuals attend, client will be billed for the number of doses needed to reach the 50 minimum.
Decision lead time	4 weeks prior to event date, however, The Wellness Company actively schedules flu clinics. Early booking secures 1st choice date.	6 weeks prior to event date, however, LES actively schedules flu clinics.
Is a consent form required?	Online registration with appointment times.	Yes. A consent form is available with online registration or at the event via tablet technology.
Do employees need to provide their Tufts Health Plan member ID card?*	Yes. Non-Tufts Health Plan members can provide another insurance card, pay directly or employer can be billed.	Yes. Non-Tufts Health Plan members can provide another insurance card (LES-accepted plans only), or employer can be billed.
