3. Tufts Health Plan will disclose Member’s information in accordance with this Authorization. Once the information is disclosed according to this Authorization, it is no longer protected by HIPAA and may be redisclosed by the Recipient.

Unless indicated here, this Authorization will remain in effect for two (2) years from the date of signature on this form (or, for a minor, the day before the minor’s 18th birthday, whichever is earlier), or there is a change to the member’s plan that may require execution of a new form.
