OVERVIEW

FDA-APPROVED INDICATIONS

Tranexamic acid (Lysteda™) is an antifibrinolytic indicated for the treatment of cyclic heavy menstrual bleeding.

COVERAGE GUIDELINES

The plan may authorize coverage of tranexamic acid for Members when **all** the following criteria are met and limitations do not apply:

- Member was started on tranexamic acid in an inpatient setting
- OR**
- The Member has a diagnosis of hereditary angioedema (HAE)
- OR**
- The Member has the diagnosis of heavy menstrual bleeding **AND** the Member tried and failed hormonal therapy, or the provider indicates clinical inappropriateness of hormonal therapy

Hormonal therapy may include:

- Oral contraceptives
- Levonorgestrel intrauterine device
- Progesterone injection

LIMITATIONS

- Requests for brand-name products, which have AB-rated generics, will be reviewed according to the Brand Name criteria.

Pharmacy Medical Necessity Guidelines have been developed for determining coverage for plan benefits and are published to provide a better understanding of the basis upon which coverage decisions are made. They include concise clinical coverage criteria based on current literature review, consultation with practicing physicians in the service area who are medical experts in the particular field, FDA and other government agency policies, and standards adopted by national accreditation organizations. The plan revises and updates Pharmacy Medical Necessity Guidelines annually, or more frequently if new evidence becomes available that suggests needed revisions.

For self-insured plans, coverage may vary depending on the terms of the benefit document. If a discrepancy exists between a Pharmacy Medical Necessity Guideline and a self-insured Member's benefit document, the provisions of the benefit document will govern.
